Dear Mon Valley CTC Wolfpack Family,


It has been a busy summer and I'm sure our students are excited to get back to school in some capacity. Your Superintendents and school leaders have worked together with Mon Valley CTC to create a schedule that puts safety at the forefront while providing the best we can for students who have committed to a career field at Mon Valley CTC. This year will be like no other as we have had to adapt and change many aspects of how we deliver Career and Technical Education. Your choice to become or remain part of the Wolfpack family will ensure you will always be essential to the workforce!

As we are a consortium of six school districts, the task of coordinating local decisions, while integrating new regulations released from various governing agencies and departments, was challenging. The schedule below reflects how we will start the school year. This schedule provides for students to be in the building no less than two sessions per week working primarily on skill development. Each student will be enrolled in our new on-line format so as to be able to learn the theory behind practical skills and apply those skills during their time in the building. The schedule holds into account sending school local decisions and their respective reopening schedules. Please understand that MVCTC must be scheduled differently than regular district schools. We must consider the class size of each program by session (AM/PM), the physical space of each program, and the individual differences between the skills taught in each program. Also, we must begin to open in a structured safe manner, therefore, this schedule must be adhered to in order to provide the best safety practices and experiences for our students.

Schedule Details and Information

- The schedule was developed to provide structure and safety while maximizing the delivery of technical education balanced with the opportunity to develop "Hands-On" skills in the building.
- Allows for every student to have access to online curriculum **and** no less than 2 sessions per week in the building to practice and develop skills.
- Bulk of time spent in labs doing "skill development" (no less than 4 hours per week) averages close to normal, as theory will be done primarily remotely.
- Provides for balanced numbers across programs and sessions based on enrollment thus promoting safety.
- Teaming provides fewer students in program areas daily.
- Provides Friday (Full Remote) for staff to prepare and record technology demonstration videos for upcoming week, grade assessments, create content and plan, etc.
- Teamed by district to provide balance and structure.



Please keep in mind:

- Only students who have registered to attend "In-Person" at their sending schools may report "In-Person" at MVCTC.
- If you have not done so already, please go to www.monvalleyctc.org and complete the brief survey.
- Transportation may be arranged through sending school districts. If your sending school calendar indicates you start later than MVCTC, you may report to MVCTC, however only during your scheduled time as per district and session (see schedule on page 1).
- MVCTC will allow families to pick up and drop off all sessions.
- Students may drive to MVCTC with parent/guardian permission. We will require paperwork to be filled out for drivers and passengers.
- We remain scheduled to open on August 24th to accommodate partner school calendars.
- Students and families must adhere to the schedule and their assigned days in order to ensure the safest environment possible.
- MVCTC will adhere to all DOH guidelines/orders regarding social distancing and face coverings.
- As per DOH orders, both masks or shields are considered acceptable face coverings.
- Uniform and locker room procedures and policies will be adapted for safety.
- Only students who previously scheduled for "In-Person" instruction at their sending school may physically report to MVCTC.
- Full time remote learners (Sending school and CTC) are expected to log in to their MVCTC google classroom August 24 to begin their 20-21 school year.
